It shows how Benedictine convents were both cut-off and enclosed yet very much in touch with the religious and political developments at home, but also proposes a different approach to the history of nuns, with a study of emotions and the senses in the cloister, delving into the textual analysis of the nuns' personal and communal documents to explore aspect of a lived spirituality, when the body which so often hindered the spirit, at times enabled spiritual experience.

In theory they were cut off from the outside world; however, in practice the nuns were not isolated and their contacts and networks spread widely, and their communal culture was sophisticated. Not only were the nuns influenced by continental intellectual culture but they in turn contributed to a developing English Catholic identity moulded by their experience in exile. During this time, these nuns and the Mary Ward sisters found outlets for female expression often unavailable to their secular counterparts, until the French Revolution and its associated violence forced the convents back to England. Inkface examines that fraternity's reading of the world as well as the ways in which those excluded attempted to counteract it.

heather daybell id: The Elizabethan Secretariat and the Signet Office Angela Andreani, 2017-03-31 This book investigates the work of the Elizabethan secretariat during the fascinating decade of the 1590s, when, after the death of Francis Walsingham, the place of principal secretary remained vacant for six years. Through original sources in the collections of the State Papers and Cecil Papers, this study reconstructs the activities of the clerks and secretaries who worked in close

contact with the Queen at court. An estimated fifty people, many unidentified, saw to every minute detail of the production of official documents and letters in an array of offices, rooms and locations within and outside the court. The book introduces the staff of the Elizabethan writing offices as a community of shared knowledge with a privileged and constant access to papers of state, working behind the scenes of court display and high politics. While the production of the state papers is explored as a means to re-construct the functioning of the inner mechanisms of state, it also provides a lens through which to access the knowledge of the administration in a pre-bureaucratic age.

heather daybell id: The Ties That Bind Bernard Capp, 2018-06-28 The family is a major area of scholarly research and public debate. Many studies have explored the English family in the sixteenth and seventeenth centuries, focusing on husbands and wives, parents and children. The Ties that Bind explores in depth the other key dimension: the place of brothers and sisters in family life, and in society. Moralists urged mutual love and support between siblings, but recognized that sibling rivalry was a common and potent force. The widespread practice of primogeniture made England distinctive. Opening up the notion of song from a performance-based perspective The Matter of Song in Early Modern England considers the implications of reading song not simply as lyric text but as an embodied and gendered musical practice.
