UNDERSTANDING HOME BURGLARY AT NIGHT

FACTORS CONTRIBUTING TO NIGHTTIME HOME BURGLARIES

POORLY LIT EXTERIORS PROVIDE COVER FOR BURGLARS TO APPROACH HOMES UNDETECTED. LACK OF MOTION-ACTIVATED LIGHTS OR SECURITY LIGHTING INCREASES THE CHANCE OF SUCCESSFUL BREAK-INS. ADEQUATE ILLUMINATION SERVES AS A DETERRENT AND IMPROVES THE EFFECTIVENESS OF SURVEILLANCE CAMERAS.

OCCUPANT BEHAVIOR

LEAVING SIGNS OF ABSENCE, SUCH AS UNCOLLECTED MAIL OR DARKENED WINDOWS, CAN SIGNAL TO BURGLARS THAT A HOME IS UNOCCUPIED. SIMILARLY, PREDICTABLE ROUTINES MAY ALLOW CRIMINALS TO PLAN BREAK-INS DURING VULNERABLE TIMES. AWARENESS AND DISCRETION IN OCCUPANT BEHAVIOR CONTRIBUTE TO REDUCING BURGLARY RISK.

PREVENTATIVE MEASURES TO PROTECT YOUR HOME
