#### ORGANIZED CRIME

ORGANIZED CRIME INVOLVES STRUCTURED GROUPS ENGAGED IN ILLEGAL ACTIVITIES SUCH AS DRUG TRAFFICKING, HUMAN TRAFFICKING, MONEY LAUNDERING, AND RACKETEERING. THESE GROUPS TYPICALLY OPERATE ACROSS NATIONAL BORDERS AND HAVE COMPLEX NETWORKS THAT CHALLENGE LAW ENFORCEMENT EFFORTS.
