If the circumstances surrounding a death are equivocal, psychological consultants can compile information retrospectively about a deceased person's mental state and possible motive to assist with unravelling ambiguity about the manner of death. In the event that the manner of death is determined to be a homicide, behavioral profiling can help to focus the potential pool of suspects.
