NAVIGATION RULES IN THE RED SEA

TRAFFIC SEPARATION SCHEMES

TRAFFIC SEPARATION SCHEMES (TSS) ARE ESTABLISHED IN THE RED SEA TO REGULATE VESSEL MOVEMENT AND REDUCE THE RISK OF COLLISIONS. THESE SCHEMES DESIGNATE LANES FOR INBOUND AND OUTBOUND TRAFFIC, OFTEN DEMARCATED BY BUOYS AND MONITORED BY MARITIME AUTHORITIES. VESSELS MUST ADHERE STRICTLY TO THESE LANES AND MAINTAIN APPROPRIATE SPEEDS TO ENSURE SAFETY.

RIGHT OF WAY AND VESSEL PRIORITIZATION

THE RED SEA RULES PRINCIPLES SPECIFY GUIDELINES ON RIGHT OF WAY, ESPECIALLY IN CONGESTED AREAS SUCH AS NEAR PORT ENTRANCES AND NARROW STRAITS. COMMUNICATION PROTOCOLS

EFFECTIVE COMMUNICATION IS VITAL FOR NAVIGATION SAFETY IN THE RED SEA. VESSELS ARE REQUIRED TO MAINTAIN CONSTANT RADIO CONTACT WITH REGIONAL VESSEL TRAFFIC SERVICES (VTS) AND OTHER SHIPS WHEN OPERATING IN

DESIGNATED ZONES. THIS FACILITATES COORDINATION, REPORTING OF NAVIGATIONAL HAZARDS, AND TIMELY RESPONSE TO EMERGENCIES.

ENVIRONMENTAL PROTECTION PRINCIPLES

AUTHORITIES COLLABORATE WITH LOCAL COMMUNITIES AND INTERNATIONAL ORGANIZATIONS TO MONITOR FISH STOCKS AND ENFORCE REGULATIONS DESIGNED TO MAINTAIN ECOLOGICAL BALANCE.

LEGAL AND REGULATORY FRAMEWORK
