The team considers all relevant information to ensure accurate classification and to avoid misidentification.

Eligibility Determination Meeting

The team, which includes educators, specialists, and the parents, convenes to discuss the evaluation results. They decide if the student qualifies for special education and identify the specific areas of need. This meeting is critical as it sets the foundation for the next phase: creating an educational plan tailored to the student.

Developing the Individualized Education Program

(IEP)

The Individualized Education Program is a legally binding document that outlines the student's unique educational goals, services, accommodations, and supports. The IEP is developed collaboratively by a team that includes the parents, teachers, specialists, and, when appropriate, the student.

Components of an IEP

An effective IEP contains detailed information about the student's present levels of academic achievement and functional performance, measurable annual goals, and the specific special education and related services the student will receive. It also specifies accommodations and modifications necessary to facilitate learning and participation in the general education curriculum.

IEP Meeting and Parental Involvement

The IEP meeting is an essential part of the special education process, ensuring that parents have an active role in decision-making. During the meeting, the team discusses the evaluation findings, drafts the IEP, and agrees on measurable objectives. Parents have the right to consent to or reject the proposed plan, and their input is highly valued throughout the process.

Placement and Services

After the IEP is developed, the next step is to determine the appropriate educational placement and services that best meet the student's needs. Placement decisions are guided by the principle of the Least Restrictive Environment (LRE), which emphasizes that students with disabilities should be educated alongside their non-disabled peers to the greatest extent appropriate.

Range of Placement Options

Placement options vary widely, depending on the student's needs, and may include:

- General education classroom with supports
- Resource room or pull-out services
- Specialized classes within the school
- Separate special education schools or programs
- Homebound or hospital instruction

The IEP team carefully considers these options to select the placement that provides optimal educational benefit while promoting social integration.

Related Services

In addition to instructional services, students may receive related services such as speech therapy, occupational therapy, counseling, transportation, or assistive technology. These services are essential components that support the student's access to the curriculum and overall educational success.

Monitoring Progress and Reevaluation

Continuous monitoring of the student's progress is a vital aspect of the special education process. The IEP team regularly reviews the student's advancement toward goals and adjusts services as needed to ensure effective support. Progress reports are typically provided to parents at least as often as report cards.

Annual Review and IEP Updates

The IEP is reviewed at least once a year to evaluate the student's progress and revise goals and services accordingly. This annual review allows the team to respond to changes in the student's needs and update the educational plan to reflect current priorities.

Triennial Reevaluation

At least every three years, a comprehensive reevaluation is conducted to determine if the student continues to qualify for special education and to assess any new or evolving needs. Reevaluation involves repeating assessments and gathering fresh data to inform future educational planning.
