OVERVIEW OF STUDENT PRIVACY POLICY NYC DOE

SCOPE AND PURPOSE

BY ESTABLISHING STRICT PROTOCOLS, THE POLICY SEEKS TO BALANCE THE BENEFITS OF DATA-DRIVEN DECISION-MAKING WITH THE IMPERATIVE OF PROTECTING STUDENT PRIVACY.

KEY PRINCIPLES

THE STUDENT PRIVACY POLICY NYC DOE IS GROUNDED IN SEVERAL KEY PRINCIPLES:

DATA COLLECTION AND USAGE

THESE INCLUDE IMPROVING INSTRUCTIONAL METHODS, MONITORING STUDENT PROGRESS, PROVIDING NECESSARY SERVICES, AND FULFILLING REPORTING OBLIGATIONS TO GOVERNMENT ENTITIES. THE POLICY PROHIBITS DATA USE FOR MARKETING OR UNRELATED COMMERCIAL PURPOSES.

DATA PROTECTION AND SECURITY MEASURES

PROTECTING STUDENT DATA FROM UNAUTHORIZED ACCESS, LOSS, OR MISUSE IS A CENTRAL COMPONENT OF THE STUDENT PRIVACY POLICY NYC DOE. THE DOE EMPLOYS A VARIETY OF SECURITY MEASURES TO MAINTAIN DATA CONFIDENTIALITY AND INTEGRITY.

TECHNICAL SAFEGUARDS

TECHNICAL PROTECTIONS INCLUDE ENCRYPTION, SECURE ACCESS CONTROLS, FIREWALLS, AND REGULAR SYSTEM AUDITS. THESE MEASURES PREVENT UNAUTHORIZED PARTIES FROM GAINING ACCESS TO SENSITIVE STUDENT INFORMATION AND HELP DETECT POTENTIAL SECURITY BREACHES PROMPTLY.

ADMINISTRATIVE CONTROLS

DATA BREACH RESPONSE

ACCESS TO RECORDS

CONSENT AND OPT-OUT OPTIONS

THE POLICY REQUIRES OBTAINING PARENTAL CONSENT BEFORE SHARING STUDENT DATA WITH THIRD PARTIES, EXCEPT IN CASES PERMITTED BY LAW. FAMILIES MAY ALSO OPT OUT OF CERTAIN DATA COLLECTION ACTIVITIES, SUCH AS PARTICIPATION IN SURVEYS OR SHARING INFORMATION FOR MARKETING PURPOSES.

CORRECTION OF RECORDS

IF INACCURACIES ARE FOUND IN STUDENT RECORDS, PARENTS AND STUDENTS CAN REQUEST CORRECTIONS OR AMENDMENTS TO ENSURE INFORMATION ACCURACY AND COMPLETENESS.

RESPONSIBILITIES OF SCHOOLS AND EDUCATORS

SCHOOLS AND EDUCATORS PLAY AN ESSENTIAL ROLE IN IMPLEMENTING THE STUDENT PRIVACY POLICY NYC DOE. THEIR ACTIONS DIRECTLY IMPACT THE EFFECTIVENESS OF DATA PROTECTION EFFORTS.

TRAINING AND AWARENESS
