CHANGES IN CLIMATE, NATURAL DISASTERS, AND RESOURCE DEPLETION OFTEN DESTABILIZE THE FOUNDATION OF SOCIETIES RELIANT ON AGRICULTURE AND NATURAL RESOURCES. WHEN ENVIRONMENTAL CONDITIONS DETERIORATE, FOOD PRODUCTION DECLINES, WATER SCARCITY INCREASES, AND LIVING CONDITIONS BECOME HARSHER.

CLIMATE CHANGE AND VARIABILITY

SHIFTS IN CLIMATE PATTERNS, SUCH AS PROLONGED DROUGHTS OR COOLING PERIODS, CAN SEVERELY DISRUPT AGRICULTURAL PRODUCTIVITY. RESOURCE DEPLETION

ECONOMIC CAUSES

POLITICAL INSTABILITY

LOSS OF SHARED VALUES

WHEN A SOCIETY LOSES ITS COMMON VALUES AND SENSE OF PURPOSE, COOPERATION DIMINISHES. THIS EROSION OF SOCIAL CAPITAL MAKES COLLECTIVE PROBLEM-SOLVING CHALLENGING AND CAN ACCELERATE DECLINE.

POPULATION PRESSURE AND URBANIZATION
