#### TITLE PAGE ELEMENTS FOR AN ANNOTATED BIBLIOGRAPHY

7. **ASSIGNMENT DUE DATE:** Two lines below the instructor's name, centered. Use the format Month Day, Year (e.g., September 15, 2023).

Even minor errors can detract from the professionalism of your work. Online citation generators can be helpful tools, but always cross-reference their output with official APA guidelines to ensure accuracy.

#### WRITING EFFECTIVE ANNOTATIONS

FOLLOWING EACH COMPLETE APA REFERENCE CITATION, YOU WILL INCLUDE THE ANNOTATION. THE ANNOTATION ITSELF SHOULD BE A CONCISE PARAGRAPH, TYPICALLY 100-200 WORDS, THAT PROVIDES A SUMMARY, EVALUATION, AND/OR REFLECTION ON THE SOURCE. - EVALUATION/ASSESSMENT: ASSESS THE SOURCE'S CREDIBILITY, ACCURACY, AND BIAS. IS THE RESEARCH METHODOLOGY SOUND? ARE THE ARGUMENTS WELL-SUPPORTED? HOW DOES IT COMPARE TO OTHER SOURCES? WHAT ARE ITS STRENGTHS AND WEAKNESSES?
- RELEVANCE/REFLECTION: EXPLAIN HOW THIS SOURCE IS USEFUL TO YOUR RESEARCH. HOW DOES IT CONTRIBUTE TO YOUR UNDERSTANDING OF THE TOPIC? DOES IT SUPPORT OR CONTRADICT OTHER SOURCES YOU'VE FOUND? HOW WILL YOU USE IT IN YOUR PAPER?

THE TYPE OF ANNOTATION REQUIRED (DESCRIPTIVE, EVALUATIVE, OR A COMBINATION) WILL DEPEND ON YOUR INSTRUCTOR'S SPECIFIC GUIDELINES. REGARDLESS, AIM FOR CLARITY, CONCISENESS, AND AN OBJECTIVE ACADEMIC TONE. AVOID PERSONAL OPINIONS UNLESS EXPLICITLY REQUESTED, AND FOCUS ON THE SCHOLARLY CONTRIBUTION AND UTILITY OF THE SOURCE.

# COMMON PITFALLS AND BEST PRACTICES FOR APA ANNOTATED BIBLIOGRAPHIES

- Lack of Hanging Indent: Failing to apply the hanging indent to the second and subsequent lines of each citation is a prevalent formatting error.
- **INSUFFICIENT ANNOTATION DEPTH:** ANNOTATIONS THAT ARE MERELY DESCRIPTIVE SUMMARIES WITHOUT ANY CRITICAL EVALUATION OR REFLECTION ON RELEVANCE MISS THE CORE PURPOSE OF AN ANNOTATED BIBLIOGRAPHY.
- Overly Long or Short Annotations: While there's no strict word count for all annotations, those that are excessively brief (e.g., one sentence) or disproportionately long (e.g., a full page) often indicate a misunderstanding of the task.
- PLAGIARISM IN ANNOTATIONS: DIRECTLY COPYING SENTENCES OR PHRASES FROM THE ABSTRACT OR TEXT OF THE SOURCE WITHOUT PROPER QUOTATION MARKS AND ATTRIBUTION, EVEN WITHIN AN ANNOTATION, CONSTITUTES PLAGIARISM.
- **INCONSISTENT FORMATTING:** MIXING DIFFERENT CITATION STYLES OR APPLYING APA RULES INCONSISTENTLY THROUGHOUT THE DOCUMENT SHOWS A LACK OF ATTENTION TO DETAIL.

DILIGENT PROOFREADING AND CROSS-REFERENCING WITH OFFICIAL APA STYLE GUIDES ARE ESSENTIAL TO MITIGATE THESE ISSUES AND PRODUCE A HIGH-QUALITY ANNOTATED BIBLIOGRAPHY.
