Abstract Formatting

No author (narrative): The report *The Future of AI* (2023) indicates...

No date (parenthetical): (Williams, n.d.)

No date (narrative): Williams (n.d.) posited that...

Creating a Comprehensive APA Reference List

The reference list provides the full publication information for every source cited in the paper, allowing readers to locate and consult the original materials. It begins on a new page after the main body of the text, titled "References" (bolded and centered) at the top. The list must be double-spaced, with a hanging indent for each entry.

Basic Reference List Structure

Each entry in the reference list generally follows a pattern of four main elements: Author, Date, Title, and Source. Other Source Types: Edited Books and Reports
