Understanding APA 7th Edition Basics

The American Psychological Association (APA) style is a widely adopted format for academic documents, particularly in the social sciences, education, and psychology. Components of a Journal Article Citation

Author(s)

Publication Year

The year of publication is enclosed in parentheses, immediately following the author(s). This indicates when the research was officially released and made available to the public. For articles published online ahead of print, a specific date or "in press" might be used if a year isn't yet assigned.

Title of Article

The title of the article is presented in sentence case, meaning only the first word of the title, the first word of the subtitle (if any), and proper nouns are capitalized. It is not italicized or enclosed in quotation marks.

Title of Periodical (Journal Name)

The full title of the journal or periodical is italicized and presented in title case, where all major words are capitalized. This helps readers identify the publication venue.

Volume Number

The volume number of the journal is italicized, immediately following the journal title. This numerical identifier typically indicates the year of publication or a sequence of issues.

Issue Number

The issue number, if available, is included in parentheses immediately after the italicized volume number, without a space between them. The issue number is not italicized. Many journals publish multiple issues within a single volume, so this helps pinpoint the exact publication.

Page Range

The page numbers where the article appears within the journal issue are listed, separated by a hyphen. This provides the precise location of the content within the physical or digital journal. If an article has an article number instead of page numbers (common in some online-only journals), use "Article" followed by the number.

Digital Object Identifier (DOI)

The DOI is a unique alphanumeric string assigned to digital academic articles, functioning as a persistent link to its location on the internet. It is typically presented as a full URL (e.g., <https://doi.org/xxxx/xxxx>). The DOI is a critical component for online articles, ensuring that the source

can be easily accessed even if the original URL changes. For articles without a DOI, a stable URL (if available and necessary for retrieval) might be included, but generally, it is omitted if the article is from a widely available academic database.

Formatting Journal Article Citations in the Reference List

The structure of a journal article reference in APA 7th edition follows a specific order and uses particular punctuation. Consistency is key for readability and adherence to style guidelines. Each entry should be double-spaced and use a hanging indent, where the first line of the entry is flush with the left margin, and subsequent lines are indented 0.5 inches.

Standard Journal Article

Journal Article with DOI

The DOI is a crucial identifier for online articles. If an article has a DOI, it must be included at the end of the reference entry as a URL. This is the most common format for contemporary journal articles.

Format: Author, A. A. (Year). Title of article. *Title of Periodical*, volume(issue), pages.

It's important to present the DOI as a full URL starting with "https://doi.org/" to ensure it is clickable

and easily accessible.

Journal Article without DOI (Print or Online without DOI)

For older print articles or newer online articles that genuinely lack a DOI, you simply omit the DOI from the reference. If the article was retrieved from an academic database and does not have a DOI, you generally do not need to include a URL or database name.

Format: Author, A. A. (Year). Title of article. *Title of Periodical*, volume(issue), pages.

Example (Print):

Thompson, R. (1995). The evolution of pedagogical methods. *History of Education Review*, 18(1), 50-65.

Example (Online without DOI, from a common database):

Kim, E. (2010). Cultural assimilation and identity formation in immigrant communities. *Sociological Perspectives*, 53(4), 512-528.

Journal Article from a Database (without DOI)

As mentioned, if an article without a DOI is retrieved from a commonly used academic research database (e.g., PsycINFO, EBSCOhost, JSTOR), you typically do not include the database name or a URL. The assumption is that these articles are widely accessible. However, if the article is from a specialized or proprietary database where the content is not broadly available, or if the database is only accessible by subscription and the article lacks a DOI, you might include the name of the database.

Example (Rare case for proprietary database without DOI):

Data Analytics Group. (2015). Trends in consumer behavior for luxury goods. *Market Research Reports*, 7(1), 1-20. Retrieved from ABI/INFORM Collection database.

In most instances, particularly for peer-reviewed journal articles, omitting the database name when there is no DOI is the correct approach.

Advance Online Publication (Epub Ahead of Print)

Sometimes, articles are published online before they are assigned to a specific volume and issue. These are known as "advance online publication" or "epub ahead of print" articles. When citing these, include the word "Advance online publication" or "Epub ahead of print" (whichever is used by the journal) and the retrieval date if the final publication details are not yet available.

Format: Author, A. A. (Year). Title of article. *Title of Periodical*. Advance online publication.

Example:

Patel, S., & Miller, J. (2023). Cognitive load and decision-making under stress. *Neuroscience Quarterly*. Advance online publication. <https://doi.org/10.1037/nq.a004567>

Once the article is assigned to a volume and issue, the citation should be updated to reflect the finalized publication details.

In-Text Citations for Journal Articles

In-text citations are brief references within the body of your paper that direct readers to the full entry in your reference list. They are crucial for acknowledging sources immediately. The APA 7th edition citation format journal article has specific rules for these short-form citations.

Parenthetical Citations

Multiple Authors

The rules for multiple authors in in-text citations changed significantly with APA 7th edition.

- **One or Two Authors:** Always include both (or the single) author's last name(s) in every citation.
 - Parenthetical: (Smith & Johnson, 2021)
 - Narrative: Smith and Johnson (2021)

- **Three or More Authors:** For three or more authors, use the first author's last name followed by "et al." in every citation, including the very first one. This is a key departure from APA 6th edition.

- Parenthetical: (Garcia et al., 2022)

- Narrative: Garcia et al. (2022)

Multiple Works

When citing multiple works within the same parenthetical citation, list them alphabetically by the first author's last name and separate them with semicolons.

Key Differences from APA 6th Edition for Journal Articles
