GENERAL ACCEPTANCE GUIDELINES

GOODWILL'S PRIMARY GOAL IS TO SUPPORT THEIR MISSION BY SELLING ITEMS THAT CAN BE RESOLD AT AFFORDABLE PRICES. TO DO THIS EFFECTIVELY, THEY CONSIDER THE CONDITION AND DEMAND FOR VARIOUS ITEMS, INCLUDING TEXTBOOKS. GENERALLY, TEXTBOOKS THAT ARE IN GOOD CONDITION, FREE FROM SIGNIFICANT WEAR AND TEAR, AND ARE UP-TO-DATE EDITIONS ARE MORE LIKELY TO BE ACCEPTED.

FACTORS INFLUENCING ACCEPTANCE

SEVERAL FACTORS INFLUENCE WHETHER GOODWILL WILL ACCEPT TEXTBOOKS:

- **CONDITION:** TEXTBOOKS SHOULD BE IN GOOD SHAPE, WITHOUT MISSING PAGES, DAMAGED SPINES, OR EXCESSIVE

HIGHLIGHTING.

- **EDITION:** CURRENT EDITIONS OF TEXTBOOKS ARE MORE LIKELY TO BE ACCEPTED DUE TO THEIR RESALE VALUE.
- **DEMAND:** IF A PARTICULAR SUBJECT OR TYPE OF TEXTBOOK IS NOT IN DEMAND, GOODWILL MAY CHOOSE NOT TO ACCEPT IT.
