In the present volume Almo Farina again addresses the subject of Landscape Ecology but from a different perspective than he took in his textbook. *Landscape in Action* focuses on the application of the principles and concepts to problem solving. The two books make a pair, with the first technical and conceptual and the second applied to problems of land and water at large scale.
